- YOU WILL BE REQUIRED TO PROVIDE A PERMIT FROM THE JEFFERSON COUNTY HEALTH DEPARTMENT BEFORE ENTERING THE GROUNDS (636.789.3372) – office open Mon-Thurs only
- ALL CONCESSIONS MUST STAY OPEN UNTIL 12:00 A.M. – NO EXCEPTIONS
- You must list all types of food products sold
- All items must be sold within space rented
- No cash raffles allowed - Hillsboro Community Civic Club has contracted with certain vendors to sell times/raffles openly on fairgrounds
- No vendor is guaranteed exclusive rights, however, we work to limit the number of concessionaires selling the same/similar products
- If you wish to be a exhibitor or vendor you must obtain a separate application
- No alcoholic beverages allowed on the fairgrounds
- The Rodeo Committee reserves the right to reject this application without explanation
- All fees and tickets are non-refundable
- Any attempt to sell or give away unauthorized items will result in removal from fairgrounds and forfeiture of funds deposited (no beverages)
- Each exhibitor/vendor is solely responsible for their own property, exhibits, or merchandise
- Each exhibitor/vendor is solely responsible for removing refuse (ie. grease, liquids)
- No pets allowed
- Vendor/Exhibitors who break down and leave early will not be asked to attend next year's event
- Everyone who comes through the gate must have a ticket
