- Table rental fee \$5 – tables limited – damage to any rented tables will require vendor to pay full cost for replacement of table
- Exhibitor locations will be assigned according to request of your business and the date in which your applications was received
- Exhibitor will have access to the grounds for set up at 6:00 a.m. on day of event
- All exhibitors/vendors are responsible for cleaning up the rented space – no trash or items may be left behind – all large trash items must be disposed of in dumpster – if dumpster is full, you must take larger trash items with you
- HCCC will be selling food for on-site consumption – similar vendors will not be allowed during this event
- All items must be sold within space rented
- Certain concessions are not permitted due to prior contractual obligations
- No vendor is guaranteed exclusive rights
- No alcoholic beverages allowed on the fairgrounds
- The HCCC reserves the right to reject this application without explanation
